#### Understanding Eligibility Requirements for Medicaid, Child Health Plus, and the Essential Plan

Eligibility requirements for these programs are established by New York State and include household income, residency, family size, and age, as well as your citizenship or immigration status\* and whether you already have other insurance.

Because the eligibility for these programs is based on more than just family size and income, it is possible that members in the same family will be eligible for different programs. Enrollment in Medicaid, Child Health Plus, and the Essential Plan is open all year long.

\*Children may be eligible for Child Health Plus regardless of immigration status.



# Qualified Health Plans on the NY State of Health Marketplace

- Routine preventive care, such as annual checkups, x-rays, and blood tests.
- Coverage for a range of medical needs, such as doctor visits, hospital stays, and prescription drugs.
- Gym membership reimbursement.
- And more.

In general, you may only enroll in a Qualified Health Plan through the NY State of Health Marketplace during the Open Enrollment Period. However, if you experience a qualifying event (such as losing health coverage due to job loss, getting married, etc.), you can sign up for health coverage during the Special Enrollment Period.
