### Policy Updates – August 2018

#### Claims must include signature on file

We want to make sure you get paid for the services you provide. And we want you to receive that payment timely. How can you help? When submitting a claim, make sure the “signature on file” field is populated. This tells our system that the payment should go to you instead of your patient. It could also help avoid unnecessary claim denials.

#### EmblemHealth now reviews Evaluation and Management services for GHI PPO claims

In March, EmblemHealth began including GHI PPO claims in the [correct coding program for Evaluation and Management](#). Codes will be reviewed to make sure they are appropriate for the level of service provided. The outcome could result in a payment adjustment if the information you submitted doesn’t support the level of service billed. Be sure to follow coding guidelines from the Centers for Medicare & Medicaid Services (CMS) to avoid complications.

#### Oncologists may be audited

A random sample of oncologists may be audited through the end of 2018 to check compliance with a new standard for appointment scheduling. When a patient has tested positive for cancer and is requesting an initial visit, oncologists are required to provide an appointment within three business days of the request.
