

## **Reduce Costs When Prescribing NSAIDs**

Non-steroidal anti-inflammatory drugs (NSAIDs), at different strengths and drug forms, can cost significantly more than other clinically comparable alternatives.

## What can you do for all of your patients?

When medically appropriate:

- Prescribe the lower cost option when introducing a new medicine.
- Speak to patients who are taking these medicines about switching to a lower cost option.
